SB 848 - Mandated Reporter Training Requirement

The safety of students in California is of utmost importance. That is why we are pleased to partner with Keenan to offer mandated reporter training to all of those who are now deemed as mandated reporters by California law.

Effective January 1, 2026, Senate Bill 848 significantly expanded those designated as mandated reporters who must complete annual child abuse prevention training. In the educational setting, these entities include:

- a **governing board member**
- a **volunteer**, defined as a person who is 18 years of age or older and who interacts with pupils outside of the immediate supervision and control of the pupil's parent, guardian, or a school employee
- a **contractor** whose duties require contact with or supervision of pupils
